Guidelines:

- Please do not send logo files to other organizations. Have them contact Kristina Kuehling at kkuehling@ohiohistory.org and she will assist them.
- Please do not display the logo as the most prominent feature on your web page without prior permission (i.e. at the top of your homepage)
- Please do not display the logo on your overall website calendar unless you have submitted a form with each event or program listed.

In order to help make the logo more effective for you, here are a few suggestions for usage.

- The logo is seen best when at least one inch in diameter.
- Both high resolution (300dpi) and low resolution (96dpi) files are available for print or web use respectively.
- Black and white versions are also available upon request.
- The Ohio Historical Society can assist with providing additional file formats, color specifications and other information that may be necessary to incorporate the logo in to your materials. Please feel free to contact us for assistance.

Ohio Civil War 150 Interpretive Framework Primary Themes

Democracy: Visions, Challenges, Breakdown and Expansion

Addresses the political turmoil in Ohio and the rest of the nation before and during the Civil War.

Includes such topics as democracy, political parties, Fugitive Slave Laws, slavery, African American equality, African Americans in the war, the election of Abraham Lincoln, and secession.

The Transformation of Ohio and America

Addresses social, political and economic changes in Ohio and the rest of the nation before, during and after the Civil War.

Includes such topics as race relations, African American equality, women, gender roles, Ohio's political leaders, economic transformations, and the relationship between state and national governments.

Memory and Commemoration

Addresses the impact of the Civil War on public memory as well as future generations' commemoration efforts.

Includes such topics as memorials, dedication ceremonies, markers, African Americans' and women's involvement in the war, veterans and descendants groups, legacy, interpretations of the war, public school education and history textbooks, and the Civil War as characterized in the media (i.e. fictional novels, Hollywood films, public television).
